

ANTI SEXUAL HARASSMENT COMMITTEE POLICY DOCUMENT



ACTIONS AND RESPONSIBILITIES

- 1. To handle with cases or Complaints of sexual magnify and any other type of Harassment of the students in the UCOP assumption.

- 3. When a senior lady staff member receives a complaint of sexual Harassment, he/she will immediately note the dates, times and facts of the incidents.




